A CONCESSIONÁRIA RODOVIAS DO CAFÉ SPE S.A., inscrita sob o CNPJ nº 51.742.485/0001-20 e na Junta Comercial do Estado de Minas Gerais ("JUCEMG") sob o NIRE 31300157288, neste ato representada por seu Diretor de Relação com Investidores, comunica aos Senhores Debenturistas, que em **28 de março de 2025** promoverá o **Resgate Antecipado Obrigatório** da totalidade das debêntures da **1ª (primeira) série da 1ª (primeira) emissão** com base no item (i) da cláusula 6.21 da Escritura de Emissão, mediante pagamento do saldo do Valor Nominal Unitário das Debêntures, acrescido da remuneração aplicável, conforme o caso, calculados com base nos termos da referida Escritura, totalizando o valor estimado de R\$ 430.099.628,00 (Quatrocentos e trinta milhões, noventa e nove mil e seiscentos e vinte e oito reais), *(1ª série - PU principal 1.000,000000 e PU juros 228,85608000)*.

O valor de Resgate Antecipado Obrigatório será pago integralmente pela Companhia por meio da B3, com relação às Debêntures que estejam custodiadas eletronicamente na B3 ou por meio do Escriturador, com relação às Debêntures que não estejam custodiadas eletronicamente na B3.

As Debêntures objeto do Resgate Antecipado Obrigatório da Primeira Série serão canceladas pela Companhia, com a conseqüente extinção de todas as obrigações da Companhia com relação à 1ª Emissão.

## **ELECTRONIC RECORD AND SIGNATURE DISCLOSURE**

From time to time, EPR LITORAL PIONEIRO S.A. (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. ### **Getting paper copies**

### **Withdrawing your consent**
