A EPR INFRAESTRUTURA PR S.A., inscrita sob o CNPJ nº 51.136.974/0001-38 e na Junta Comercial do Estado de São Paulo (“JUCESP”) sob o NIRE 35.300.618.041, neste ato representada por seu Diretor de Relação com Investidores, comunica aos Senhores Debenturistas, que em **16 de junho de 2025** promoverá a **Amortização Extraordinária Facultativa** de 28,23% do valor Nominal Unitário das Debêntures da **série única da 2ª (segunda) emissão**, com base no item (ii) da cláusula 6.20 da Escritura de Emissão, mediante pagamento da parcela do Valor Nominal Unitário das Debêntures, acrescido da remuneração incidente sobre a parcela do Valor Nominal Unitário das Debêntures aplicável, conforme o caso, calculados com base nos termos da referida Escritura, totalizando o valor estimado de R\$ 73.780.761,47 (setenta e três milhões, setecentos e oitenta mil, setecentos e sessenta e um reais e quarenta e sete centavos), *(série única - PU principal 282,30000000 e PU juros 1,47215949)*.

O valor da Amortização Extraordinária Facultativa será pago integralmente pela Companhia por meio da B3, com relação às Debêntures que estejam custodiadas eletronicamente na B3 ou por meio do Escriturador, com relação às Debêntures que não estejam custodiadas eletronicamente na B3 com recursos depositados na conta vinculada.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, EPR LITORAL PIONEIRO S.A. (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. Consequences of changing your mind

To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. If you do not agree with this process, please let us know as described below.
