ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, R. AMARAL, HULAND, CASTRO ALVES, LINHARES & BARROS LEAL ADVOGADOS (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
